AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT
ACCEPTING A GRANT AWARD FROM THE NEW YORK STATE OFFICE OF
CHILDREN AND FAMILY SERVICES SUPPLEMENTING THE
IMPLEMENTATION AND OPERATION OF THE 2025/2026 ADVANCING
LEADERSHIP INITIATIVES FOR TEENS PROGRAM**

WHEREAS, the New York State Office of Children and Family Services (NYSOCS) has awarded the City of Peekskill Youth Bureau Twelve Thousand One Hundred and Sixty-Six and 00/100 (\$12,166.00) Dollars to supplement the implementation and operation of the 2025-2026 Advancing Leadership Initiatives for Teens (LIFT) program; and

WHEREAS, the LIFT program reflects the positive youth development model focusing on providing opportunities for youth to actively acquire skills and abilities to become competent, caring and healthy adults; and

WHEREAS, the LIFT program is a holistic, 12-month youth development program including summer services; and

WHEREAS, funds received from this grant will be recorded in revenue line, 015.0015.4793.0622, L.I.F.T.; and

WHEREAS, NYOCS grant funding for these services requires no matching funds from the City of Peekskill; and

WHEREAS, the NYSOCS grant funding will be for a 1-year period, commencing October 1, 2025, continuing through September 30, 2026.

NOW THEREFORE, BE IT

RESOLVED, that the City Manager or his designee is hereby authorized to enter into an agreement to accept grant funding in the amount of twelve thousand one hundred and sixty-six and 00/100 (\$12,166.00) from the NYSOCS to supplement the implementation and operation of the LIFT program operated by the City of Peekskill Youth Bureau; and be it further

RESOLVED, that the agreement shall be subject to the review and approval of the City Manager and City Attorney; and be it further;

RESOLVED, that the City Manager or his designee is authorized to take any actions necessary to effectuate the intent of this Resolution; and be it further

RESOLVED, that this Resolution take effect immediately.
