### **CEEP Update**

- Municipal Investment Fund Phase I application for City to ICLEI and the Coalition for Green Capital
- These funds are intended to fill gaps in capacity and technical expertise to create roadmaps for public-private partnerships which make NCIF projects (clean energy projects) possible

#### Meeting with City Manager on Monday 02/09

- Tree Ordinance suggestions reviewed, another meeting scheduled for March with Chris Gross and Carol Samol
- Food Scraps structure is planning to be built by new hire in DPW
- 7 trees planted by DPW
- City website changes: agendas and minutes being posted. \*\*\*NEED: rewrite of the CAC description and explanation of what we do\*\*\*\* Current about us is outdated. Kay will take a look at a rewrite. Pamphlets are not loading - error 404

#### New Method of Approving Minutes

- After meetings, Emma will send all members the minutes, members respond with yes or no, suggestions, etc. Then the minutes will be posted to the City website ASAP.

#### Lake Mitchell Sustainable Practices

- New maintenance proposed at Lake including chemical treatment of the lake. J Zamora reached out for CAC input
- Suggestions to use the previously used more natural treatment methods, which are also less expensive. Previous method for preventing algae was treatment with competitive bacteria, barley islands, and straw added. Money is better spent remediating the phragmites- how can this be done without an excavator?
- City Manager arranged meeting between the former lake manager, Jan, and J. Zamora

#### Education and Tabling

- Events to table at spring, summer, fall: Need members to step up to carry out all steps needed to plan and cover these events; below are members who are looking into events.

    - 2025 collaboration with Anthony Carbone, Farmer's Market, and food scraps drop off. This year: do not want to attend every single farmer's market meeting.

    - Deb and Lise are working with parks
  - Saturday Academy March 15, and possibly, April 26 and May 31 - Kay, Deb, Courtney; Jan is available, as needed.
    - Is a zero waste event which collects food scraps
    - Also recruit students! They can get some volunteer hours helping table and set up for the CAC
    - Set up a demo for kids with microscopes to explain food scraps process
    - Event is designed to be activities between kids and parents
    - Ask Anthony for some bags of compost to use in demo
    - Ask Travis at WASS for demo materials
  - Earth Day (PHS, nearby municipalities?)
  - Other events: Irish Fest, Nashkill
