- G. Upon approval of this application, permit and approved plans and specifications, shall be kept on the premises available for inspection throughout the progress of work.
- H. No building shall be occupied or used in whole or in part for any purposes until an application is made for, and a Certificate of Occupancy shall have been granted by the Building Department.
