Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Promoted the FSS Program to Foster Self-Sufficiency

Actively promoted the Family Self-Sufficiency program to encourage participants to pursue higher education, develop job skills, and achieve increased employment opportunities.

Enrolled and Engaged 25 Participants in the FSS Program

Successfully enrolled 25 individuals into the Family Self-Sufficiency program and are actively supporting them in achieving their personal and professional goals.

Monitored Staff Performance to Ensure Accurate Rent Calculations

Conducted regular monthly and quarterly performance reviews of staff's recertifications and interims to ensure accurate rent determinations and compliance with HUD regulations.

Developed Multilingual Recertification Packets

Created and distributed Recertification Packets in Arabic, Russian, and Spanish to improve accessibility and ensure inclusivity for non-English-speaking clients.

Continued Fair Housing Training for Staff

Provided ongoing training on Fair Housing laws and policies to ensure staff are equipped to deliver equitable services to all clients.

Admitted 20 New Families into the Program

Successfully admitted 20 new families into the housing program, expanding support to more households in need.

Enforced Inspection Compliance and Addressed Deficiencies

Ensured that all inspection deficiencies were addressed promptly and enforced corrective actions with landlords, including abatement when necessary. Maintained an 85% success rate in scheduling initial inspections within 10 to 15 days, ensuring they are completed in a timely manner.

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
