Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Conducted four presentations to different Real Estate Agencies (Berkshire Hathaway, PNC Realty and Coldwell Banker) to explain the HCV Program to newly hired real estate agents at these companies. Continued to conduct Move-Out Inspections for ensure tenant's are maintaining their units within housing quality standards. Continued to conduct Quality Control Inspections to ensure the safety of the tenant in the unit, assist the Owners in their own quality control of the units and to make sure the units are meeting housing quality standards. Created advisement inspections to encourage more landlord participation on the program. These advisement inspections are meant for landlords who are hesitant about participating in the program due to their units' compliance with housing quality standards. These inspections are given as a courtesy to landlords who would like to rent their units with us but are unsure if their unit would pass our inspection. We would advise them on what they can do to their unit to ensure it passes housing quality standards. This was an innovative way for our agency to increase landlord participation in the program. Utilizing an Electronic File Management Software to have all our files paperless. Increased our program participants by 22 families from January 2022 to present. Continued our outreach efforts to get potential landlords on the program through phone meetings and Zoom meetings. Conducted two tenant workshop presentations to discuss how their rental subsidy is calculated. Continued to ensure rents for units are fair and within rent reasonableness. Worked on reducing non-compliance participants in the HCV Program through effective communication. Prosecuted non-compliance cases when necessary and continued to demand repayment of federal subsidy when appropriate. <p>Goals for 2023</p> <ul style="list-style-type: none"> Anticipate opening the HCV Program waiting list in 2023 to accept new applications. Continue to maintain our "High Performer Status" on HUD SEMAP Continue to increase our voucher utilization. Have all our participant files paperless by 2023. We are at about 75% of all our files being scanned electronically. Look into establishing a Section 8 Home Ownership Program. When applications are being accepted with HUD look into bringing a Family Self-Sufficiency Program to the City of Peekskill. Continue to educate our participating families on their subsidy and work with community agencies on other programs to promote self-sufficiency for our clients. Have more presentations about Fair Housing during Fair Housing Month in April 2023. Maintain high levels of standards and professionalism in management of program activities and operations.
